

# Unicode request for Saudi riyal sign

This proposal is for the Saudi currency sign introduced in 2025, <ﷲ>. The design is a ligature of the Arabic word رِيَال *riyāl*, with the letter *r* turned across the letters alif and *l* like the cross-bar in other currency symbols. It is similar to the symbol for the Iranian currency, U+FDFF رِيَال, RIAL SIGN, which in some typefaces has a similar ligature, e.g. <ﷲ> in Adobe Arabic and <ﷲ> in Noto Naskh Arabic, but the Saudi character is intended for both RTL and LTR text whereas U+FDFF is specifically RTL. The Saudi symbol is officially placed to the left of a number and separated with a space (Figure 2).

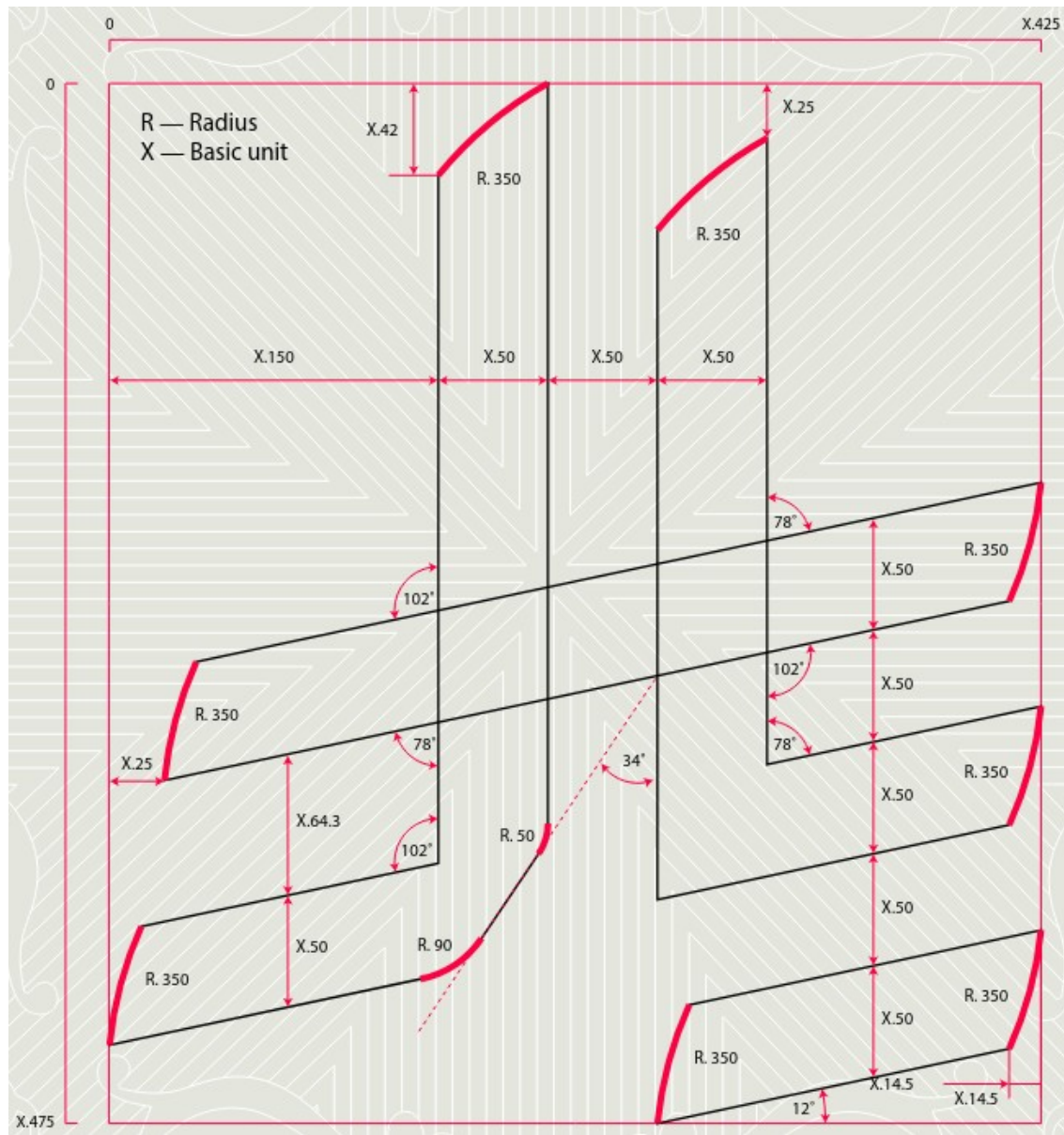


Figure 1. Saudi Central Bank (2025). Design of the symbol.
