This symbol has been designated as the official representation of the Saudi Riyal for use in financial, commercial, and digital transactions.

In line with Saudi Arabia's Vision 2030, which prioritizes financial modernization and digital transformation, we respectfully submit a formal request for the Unicode Consortium to register the Saudi Riyal symbol in the Currency Symbols block of the Unicode Standard. ## Introduction

On February 20, 2025, the Custodian of the Two Holy Mosques, King Salman bin Abdulaziz Al Saud, approved the creation of the Saudi riyal symbol for representation of the Saudi riyal currency in text. This symbol was designed in collaboration between the Saudi Arabian Central Bank; the Ministry of Culture; the Ministry of Media; and the Saudi Standards, Metrology and Quality Organization. The new symbol was announced on February 20, 2025 and recommended for immediate usage in finance and commerce.

#### Custodian of Two Holy Mosques Approves Saudi Riyal Symbol



Saudi Riyal symbol with original size/proportion






